Consent for the insertion of objects into my anus

I, [Name Redacted] of, at the time of signing, [Address Redacted] hereby give permission to [Name Redacted] to require me to insert objects of his choice into my anus.

I understand that [Name Redacted] may transfer these rights to other people by completing the document entitled "Transfer of slave Ownership". I further understand that I will have no say in who these rights are transferred to and agree to be bound by this document on transfer of his rights to a third party. I understand and agree that any future holder of these rights over me may choose to transfer them to another party without my permission by completing further "Transfer of slave Ownership" documents.

I agree that, from this point onwards, my anus will always be filled with a butt plug, anal ball, dildo, penis, fingers, fist, or any other object specified by the holder of these rights over me. I agree that the only exceptions to this will be when I am cleaning or cleaning my anus, when I am changing the object currently inserted to a different one, when I am being used sexually and this act requires me to remove any object, or when I have sought and been given permission from the holder of these rights over me.

I agree that the default object in my anus will be a butt plug specified by the holder of these rights. If this is not available and no other object has been specified, I will use 2 of my fingers. I further agree and understand that my anus may be stretched to allow it to take larger and larger objects. This may become permanent, and I agree that no further consent will be necessary to do this. I understand that lube may or may not be permitted when inserting an object. I understand that I will be required to use my common sense regarding what I insert and when. For example, if a dildo is placed on a chair and I am told to sit on the chair I would remove the object currently in my anus and replace it with the dildo before sitting. I understand that multiple items may be inserted at once, that any object or objects maybe inserted and removed rapidly multiple times emulating anal sex.

I understand that an object could be inserted at any time and place and without further consent from me. I understand that a harness may be used to keep objects securely inserted in my anus and that objects may be locked in place without any further consent from me, but any such object will be removed to allow me to clean and defecate.

I understand that some objects inserted fitted may be large and difficult to wear, meaning they will be difficult or impossible to hide under everyday clothing or will change the way I am able to walk or move. I will make no attempt to remove, damage or break anything inserted into my anus. I understand that I may be required to display any inserted object, in situ, to anyone I am asked to at any point in time or location. I understand that I am to make no attempt to hide the object when naked or dressed in fetish gear, even in public places such as changing rooms, and am to answer any questions about it honestly.

By signing this form, I hereby release, forever discharge and hold harmless the above-mentioned people from any and all claims for liabilities and damages and will not hold them liable for any criminal or civil proceedings arising from or connected to the procedure undertaken. I am executing this indemnity form with full knowledge and understanding to its legally binding effect. I acknowledge that I am of legal age giving my full consent to this indemnity agreement, without representation, inducement, or coercion.

The above is granted in perpetuity to the aforementioned people and I waive any rights or	ability	to
revoke this permission. I agree to submit to punishment should this contract be broken.
