

Consent for Permanent or Temporary Chastity

I, [Name Redacted] of, at the time of signing, [Address Redacted], hereby give permission to [Name Redacted] to seal my penis temporarily or permanently into a chastity cage. I understand that when in chastity I will be denied physical access to my penis and possibly my testicles and other parts of my body. This means I will lose the ability to have sex, masturbate and perform some natural bodily functions, such as the ability to orgasm or ejaculate through stimulation of my penis.

I understand that [Name Redacted] may transfer these rights to other people by completing the document entitled "Transfer of slave Ownership". I further understand that I will have no say in who these rights are transferred to and agree to be bound by this document on transfer of his rights to a third party. I understand and agree that any future holder of these rights over me may choose to transfer them to another party without my permission by completing further "Transfer of slave Ownership" documents.

I consent to any type of device being fitted to me for any duration of time. I understand that some devices could be, among other things, secured to my testicles, around my waist, through piercings or any combination of those. I further understand that devices may contain portions that invade my urethra or anus. I consent to devices of any size being fitted and understand that this could mean that my penis is restricted to a shorter length than it is naturally. I agree to devices being fitted that could cause further discomfort or pain, such as but not exclusively electric shock or spiked devices. I realise that devices may be uncomfortable to wear, especially when erect and may cause my testicles, anus, and urethra to be stretched, change how I walk or cause other changes to my body. I understand that any changes to my body caused by a chastity device could be permanent.

I understand that a device can be fitted at any time and without further consent from me. I understand that they may be permanently locked on without any further consent from me and that appropriate locking mechanisms to ensure I can never remove them may be fitted, for example using rivets, welding compounds or permanent locks. I understand that in this case I am likely never to touch my penis, masturbate or have sex again and as a result my life will change dramatically.

I understand that some devices fitted might be bulky and difficult to wear, meaning they will be difficult or impossible to hide under everyday clothing. I understand that any device fitted to me remains the property of the person who fitted it and as such I will make no attempt to remove, damage or break it. I understand the device's owner may require me to display it, in situ, to anyone they wish. I understand that I am to make no attempt to hide the device when naked or dressed in fetish gear, even in public places such as changing rooms, and am to answer any questions about it honestly.

By signing this form, I hereby release, forever discharge and hold harmless the above-mentioned people from any and all claims for liabilities and damages and will not hold them liable for any criminal or civil proceedings arising from or connected to the procedure undertaken. I am executing this indemnity form with full knowledge and understanding to its legally binding effect. I acknowledge that I am of legal age giving my full consent to this indemnity agreement, without representation, inducement, or coercion.

The above is granted in perpetuity to the aforementioned people and I waive any rights or ability to revoke this permission. I agree to forfeit my television and associated equipment to [Name Redacted] or any other holder of these rights over me for the period of 2 months & submit to punishment for each infraction of the terms of this document.
