

# Consent to be Monitored and Controlled

I, [Name Redacted] of, at the time of signing, [Address Redacted], hereby give permission to [Name Redacted] to monitor and control any element of my life that he wishes to, in any way that he wants to.

I understand that [Name Redacted] may transfer these rights to other people by completing the document entitled "Transfer of slave Ownership". I further understand that I will have no say in who these rights are transferred to and agree to be bound by this document on transfer of his rights to a third party. I understand and agree that any future holder of these rights over me may choose to transfer them to another party without my permission by completing further "Transfer of slave Ownership" documents.

I understand that any part of my life may be monitored. I consent to any form of tracking software being installed on any or all of my devices such as phones, PCs, laptops etc. I understand that any such software will be invasive and monitor things such as my location, websites I visit, what I type, the content on the device and other things. I understand and agree that I may be required to carry or have fitted to me devices, such as tracking devices that monitor my location and other any other device that helps the holder of these rights over me to track me as much as they wish. I understand that some devices may have to be locked on, such as ankle bracelets and others, such as NFC chips may be installed under my skin. I consent to these, and other invasive devices, being fitted. I agree to submit any digital device, physical device or device installed on me for checks by the holder of these rights at any time or place.

I understand that photographic evidence may be required to be sent to the holder of these rights in order to prove I am where I am supposed to be, wearing what I am supposed to be wearing or doing the task I am supposed to be doing. I agree to provide this within a timely manner. I also agree to security cameras being installed in my home to allow 24/7 monitoring and no privacy. I understand that these may be connected to the internet

I agree to an unlimited amount of control being placed upon me by the holder of these rights. I understand that this will include where I can go and when, what I can spend money on, who I can socialise with, what I can wear, when I can use the toilet, how I perform any task or any other form of control. I understand that any and all aspects of my life can be controlled but I will continue to manage household bills without any restriction. I agree that electronic devices such as and other equipment may be used to help control me. Such devices may take the form of but are not limited to restraints, devices that provide a safe electric shock should I stray to an area I shouldn't be in or make too much noise, anal plugs, chastity cages, muzzles, alarms or techniques such as hypnosis.

I will not attempt to remove any device or software used to monitor or control me.

By signing this form, I hereby release, forever discharge and hold harmless the above-mentioned people from any and all claims for liabilities and damages and will not hold them liable for any criminal or civil proceedings arising from or connected to the procedure undertaken. I am executing this indemnity form with full knowledge and understanding to its legally binding effect. I acknowledge that I am of legal age giving my full consent to this indemnity agreement, without representation, inducement, or coercion.

The above is granted in perpetuity to the aforementioned people and I waive any rights or ability to revoke this permission. I agree to forfeit my television and associated equipment to [Name Redacted] or any other holder of these rights over me for the period of 2 months & submit to punishment for each infraction of the terms of this document.
