Consent to be punished

I, [Name Redacted] of, at the time of signing, [Address Redacted], hereby agree to submit to any and all 'punishments' give permission given to me by [Name Redacted] I agree that any such punishment may take various and multiple formats, for example corporal punishment, beatings or psychological punishment.

I understand that [Name Redacted] may transfer these rights to other people by completing the document entitled "Transfer of slave Ownership". I further understand that I will have no say in who these rights are transferred to and agree to be bound by this document on transfer of his rights to a third party. I understand and agree that any future holder of these rights over me may choose to transfer them to another party without my permission by completing further "Transfer of slave Ownership" documents.

Relating to corporal punishments and beatings, I understand and agree that the holder of these rights over me may choose to use their bare hands or implements such as but not limited to canes, whips, cat-o-nine tails, belts and household implements. I understand that these types of punishments may be severe and/or of a long duration and may leave lasting marks on my body. I understand that care will be taken so that these can be hidden by clothing but on occasion they may accidentally spread to other areas. I understand that punishments may be extremely painful but will not lead to me being maimed or permanently harmed.

Relating to psychological punishments, I understand and agree that they may cause me to experience a range of emotions and that they will be designed to have psychological effect on me that may alter my behaviour. They may include dark and/or confined spaces, humiliation, restrictions, or any other aspect that doesn't fit in with the traditional definition of corporal punishment or beatings.

I agree that I may be punished for any reason or no specific reason as the holder of these rights over me requires. I understand that a reason may or may not be given. I further understand that I may be punished in private or public but never in front of family and that any punishment carried out will be appropriate to the situation and location I am in. I agree that others may be invited to watch or participated in any punishment and that I may be required to show the marks left to other people at any time. I agree that I am not to interrupt any punishment and am to remain as quiet as possible while they are being carried out. I agree that any punishment that is interrupted either by myself or for another reason will start from the beginning again. I may not be informed in advance of any punishment. I may only refuse a punishment or interrupt it if I feel I am in serious danger of harm. I will have to justify this. Where this is the case a modified version of the punishment will be carried out twice in quick succession to compensate. I may only interrupt a punishment by using the word 'pineapple'. Where I am unable to speak another way of communicating that I am in danger will be agreed upon prior to any punishment.

By signing this form, I hereby release, forever discharge and hold harmless the above-mentioned people from any and all claims for liabilities and damages and will not hold them liable for any criminal or civil proceedings arising from or connected to the procedure undertaken. I am executing this indemnity form with full knowledge and understanding to its legally binding effect. I acknowledge that I am of legal age giving my full consent to this indemnity agreement, without representation, inducement, or coercion.

The above is granted in perpetuity to the aforementioned people and I waive any rights or ability to revoke this permission. I agree to forfeit my laptop computer to [Name Redacted] or any other holder of these rights over me for the for the period of 1 month & submit to further punishment for each infraction of the terms of this document.
