

# Agreement to dress and look as instructed

I, [Name Redacted] of, at the time of signing, [Address Redacted], hereby give permission to [Name Redacted] to decide what clothing I am to wear, or not wear at any time.

I understand that [Name Redacted] may transfer these rights to other people by completing the document entitled "Transfer of slave Ownership". I further understand that I will have no say in who these rights are transferred to and agree to be bound by this document on transfer of his rights to a third party. I understand and agree that any future holder of these rights over me may choose to transfer them to another party without my permission by completing further "Transfer of slave Ownership" documents.

I agree that when naked or clothed I will wear any chastity or BDSM gear I am expected to wear and not attempt to remove it. I understand underwear and socks are never to be worn. Normally, a weekly schedule of what I am to wear will be given to me. I agree to wear what is contained in it. However, when this isn't provided I agree to wear the following:

- I consent and agree to be naked when at home or at the home of the holder of these rights over me, unless instructed otherwise or vanilla guests or family are present.
- I understand that I will be provided with a pair of rubber shorts and agree only to wear them only when answering the door, dealing with unexpected callers (excluding family) when in the garden or any other publicly visible area.
- I also understand that I will be provided with a wet look or rubber vest. I agree to only wear this when permission has been fully granted and understand this will be rare.
- Where vanilla guests or family are present or I am in public I agree to wear rubber shorts with the rear zip open, with a smart shirt and tight, smart jeans that have been fitted with a hidden rear zip, braces and military style boots.
- For work I agree to wear a onesie type t-shirt fastened around my crotch, smart jeans, smart shirt and smart shoes.

I further understand and agree that the holder of these rights can change and alter the standard set of clothing at any time without notice, in line with my hard limits. They can equally demand that I wear specific clothing at any time regardless of any schedule set. I fully understand that clothing may be skimpy or humiliating and may make it difficult or impossible to hide any BDSM gear attached to me. I understand and agree that I may be required to wear BDSM clothing, gear or devices in appropriate public settings which will be plainly visible and not hidden in any way. Likewise, I understand that I may be required to be partially or fully naked in appropriate BDSM friendly locations.

I agree to have my hair cut in a way that suits the owner of these rights over me to help complete his desired look for me. Unless told otherwise I will ask for a grade zero on the back and sides with a short mohawk on top. I will get my hair cut every 5 weeks. I understand that the holder of these rights over me may choose to cut my hair himself. I further understand that I am required to remove all hair below my head and to remain clean shaven. I understand and agree that I am to wear a retainer in my septum piercing when in vanilla settings, with family or for work. At other appropriate times I am to wear a ring. I agree to wear rings in each nipple when at work, with family or in a vanilla setting but will replace these with shields and stirrups when in appropriate settings. I further agree to wear the appropriate agreed upon jewellery in all other piercings.

By signing this form, I hereby release, forever discharge and hold harmless the above-mentioned people from any and all claims for liabilities and damages and will not hold them liable for any criminal or civil proceedings arising from or connected to the procedure undertaken. I am executing this indemnity form with full knowledge and understanding to its legally binding effect. I acknowledge that I am of legal age giving my full consent to this agreement, without representation, inducement, or coercion.

The above is granted in perpetuity to the aforementioned people and I waive any rights or ability to revoke this permission. I agree to forfeit my phone to [Name Redacted] or any other holder of these rights over me for the period of 2 weeks & submit to punishment for each infraction of the terms of this document.
