## Consent for BDSM activities

In addition, I agree to complete any BDSM task given to me and to not refuse any that are in line with my hard limits.

I understand that [Name Redacted] may transfer these rights to other people by completing the document entitled "Transfer of slave Ownership". I further understand that I will have no say in who these rights are transferred to and agree to be bound by this document on transfer of his rights to a third party. I understand and agree that any future holder of these rights over me may choose to transfer them to another party without my permission by completing further "Transfer of slave Ownership" documents.

I fully understand and agree that any activity may temporarily or permanently modify the way I behave, move or the way I look. I further understand that activities may include but is not limited the use of light bondage, heavy bondage, gags, suspension, chastity, and other types of restraints; spanking, flogging, caning and other impact activities; sexual activity with single or multiple consenting adults, sexual activity with inanimate objects/toys; electric shocks, hot wax, ice, water torture, exposure to light and dark, sensory deprivation and other types of sensation play; verbal, public, private and other types of humiliation; suction cups, cock torture, ball torture and other types of body part torture; forced haircuts, stretching of body parts, piercings, tattoos, pumps, infusions and other types of body modification; leather, rubber and other fetish gear; serving as a butler, toilet, astray, furniture, being interrogated, age play or other roleplaying activities; butt plugs, anal toys, sounds and other invasive activities; Forced servitude speech restrictions, rituals, loss of decision making, domestic service and other activities relating to service and restrictive behaviour; forced nudity, videoing, porn watching, and other voyeurism and exhibitionism activities, urine related activities, catheterisation, toilet use control, seamen eating, enemas and other activities involving bodily functions and fluids, hypnosis, brainwashing, mild and severe pain, breath control and any other activity that falls within the BDSM lifestyle I have chosen. All activities will be in line with my current hard limits & I understand that legal substances may be used in any activity.

I understand and agree that a where devices such as BDSM Equipment or Fetish Gear are to be used that they can be fitted at any time and without further consent from me. I understand that they may be permanently or temporarily locked on without any further consent from me and that appropriate locking mechanisms to ensure I can never remove them may be fitted. I understand that some equipment, devices or gear fitted might be bulky and difficult to wear, meaning it will be difficult or impossible to hide under everyday clothing. I understand that anything fitted to me remains the property of the person who fitted it and as such I will make no attempt to remove, damage or break it. I understand the holder of these rights over me may require me to display gear and other equipment and devices, in situ, to anyone they wish. I understand that I am to make no attempt to hide them when naked or dressed in general fetish gear, even in public places such as changing rooms, and am to answer any questions honestly.

I further understand and agree that any BDSM task or activity can happen at any time and place. I further understand that tasks and activities can last for any duration of time, be it minutes, hours, weeks or years. I agree not to complain or comment on any discomfort or pain caused by any BDSM task, activity or experiment but will give my honest opinion and thoughts if asked. I understand that any BDSM activity could cause me to make involuntary noises, such as screams, crying or laughing. I agree to keep any noise to a minimum and agree that if I am making too much noise during any BDSM activity that I may gagged or muzzled and subjected to corporal punishment. I agree that any BDSM activity may be carried out in part or full in front of a single or multiple consenting adults and that they may be invited to participate in any appropriate way.

By signing this form, I hereby release, forever discharge and hold harmless the above-mentioned people from any and all claims for liabilities and damages and will not hold them liable for any criminal or civil proceedings arising from or connected to the procedure undertaken. I am executing this indemnity form with full knowledge and understanding to its legally binding effect. I acknowledge that I am of legal age giving my full consent to this indemnity agreement, without representation, inducement, or coercion.

The above is granted in perpetuity to the aforementioned people and I waive any rights or ability to revoke this permission. I agree to forfeit my television, gaming consoles and laptop computer to [Name Redacted] or any other holder of these rights over me for the period of 6 months & submit to punishment for each infraction of the terms of this document.
